You will read an article that discusses the issue of privacy and computers. You will then read an essay that summarizes and responds to the article.

A *Before You Read* What are some possible dangers of surfing the Internet? What can people do to protect themselves from these dangers? Read the article. Then read the response to the article below it. What do the two writers suggest as ways Internet users can protect themselves?

Privacy and Computers

In an era of online social media, people can announce any event to their virtual network of friends, family, and acquaintances within moments. From birthday celebrations to baby pictures, friends get news about each other from texts, tweets, or social networks. In addition, many people use credit cards to purchase products and complete numerous online forms with personal information for a variety of purposes. As a result, personal information is ending up in the hands of other people. There are critics who are concerned by the lack of privacy. Despite such concerns, by following a few common-sense measures, people can use the Internet enjoyably and safely.

In our fast-paced world, social networking sites are, for many people, an important way to keep up with friends and family. The issue now is how open one should be with sharing private information since the information could be stolen by criminals. For example, some people have had their homes broken into because they had posted the details of their vacation online. If they had not posted those details, the thieves would not have known that they had gone away. One way to reduce the risk of this happening is to activate the privacy controls on social networking sites and smartphones. In other words, think about who will see your information and consider how they might use it.

Another important step is to shop only on secure websites so that one's accounts, passwords, and financial records are protected. Some experts recommend that people should treat their online information like they would treat the contents of their wallets. For example, a man bought merchandise on a website that did not have a security padlock, and as a result of this transaction, his bank accounts were emptied. If he had paid attention to the security on the site, he would not have lost his money. However, it appears that people are becoming more aware of the risks of fraud and taking steps to avoid them since the total percentage of

incidences of fraud remained steady in 2011 (Campana, 2012). It may be that people who have 25 grown up using the Internet understand its risks as well as its strengths.

The ease of sharing information provides opportunities for crimes and abuses. While it may be impossible to entirely eliminate the risks, if people followed reasonable guidelines to protect important data, they could greatly reduce these risks. The benefits of being able to do such things as bank online, keep medical records updated almost instantly, and share the thrills both 30 big and small of everyday life with friends outweigh these concerns.

Summary-Response Essay on "Privacy and Computers"

Robert Erani, in the article "Privacy and Computers," explains the issues concerning the sharing of personal information online. According to Erani, one area of concern is that people may sometime share details of their lives online without thinking about the consequences. As the author points out, 5 "The issue now is how open one should be with sharing private information since the information could be stolen by criminals" (para. 2). The author describes a situation in which people were robbed after revealing their vacation plans online. The author further states how important it is for consumers to protect their personal information when they purchase 10 products online. Erani concludes the article by stating that, despite the concerns about privacy, one can still use online services safely by using common sense and privacy controls.



In sum, the author provides a general introduction to the issues of privacy online and offers some advice on how to avoid problems. I agree that insecure websites are 15 a problem, but I disagree with the author's contention that people who have grown up using the Internet are more savvy about using it. Hackers and scammers continue to come up with more sophisticated and convincing schemes. The consumer needs to constantly be wary of them. In addition, the article fails to address the more controversial issues concerning the consequences of posting information regarding 20 health issues, job dissatisfaction, or even political views. This is an oversight because these issues impact individuals every day. It is becoming increasingly common for employers, for instance, to view the online profiles of potential employees as part of their selection process. Despite these shortcomings, the author rightly states that the concern around privacy issues seems to be an acceptable exchange for many 25 people for the benefits of sharing their lives with others.

3 Common Phrases Used in Summary-Response Writing

Vocabulary Presentation

Good academic writers use phrases appropriate to introducing and identifying ideas in summary-response writing.

The article **provides** a thorough introduction to the issues of privacy. The author fails to address more controversial concerns.

3.1 Common Phrases in Summary–Response Writing

a. You can use these common subject + verb combinations to introduce the main idea of a summary. They are listed in order of frequency:

The article + say, state, note, describe, mention, quote, report ...

The author + claim, explain, call, say, write, arque, cite, establish, start...

The article is used much more frequently than the author in summary-response statements.

Note: Do not use believe or think in summary-response statements that begin with the words "The author . . . "

b. The common subject + verb combinations in (a) are usually used in the present but sometimes also appear in the simple past or present perfect.

(See Unit 14 on reporting verbs.)

The article describes the problem of privacy and computers.

The article mentions ways that education can prevent problems with technology.

The author starts the article by saying that technology is part of everyone's lives.

The author claims that the experts he interviewed for this article were well-known.

NOT The author thinks that the experts he interviewed for this article were well-known.

The article quoted many well-known sources. The author has argued that individuals are responsible for protecting their own privacy.

Policy at San Diego State University, addresses/claims the issue of privacy in the Internet age in his article "Growing Concerns Over Internet Privacy" (2010). He

15 Collins goes on to recommend ways users can limit the possibility of security and privacy violations. Because SNSs are getting so big, he says, it is becoming impossible to monitor the activity that takes place on them. It is therefore the responsibility of users to take precautions as they share information about themselves. Collins concludes that there probably will never be a solution to these issues and implies that we will have to put up with threats to our privacy $_{\rm 20}\,$ and security. Collins adds, however, that the less one uses SNSs, the lower the chance one has of getting their identity stolen.

5 The Writing Process

In this section, you will write a two-paragraph summary–response to an article about a topic on technology. Before you start writing, you will learn about summary–response writing.

About Summary–Response Writing

Being able to create strong summary-response writing is an important skill for academic writers. Academic writers have to be able to show that they understand the ideas put forward by others and how those ideas fit into their own worldview.

The following are guidelines for writing a summary-response of an article:

- 1. Identify the writer's main ideas. While reading the original text, use a highlighter or take notes that show what the writer's main ideas are.
- 2. Make notes about your own ideas. Review your highlighted text and notes and then make more notes indicating which points you agree or disagree with.
- 3. State your source at the beginning of the summary–response. Begin your summary by giving the name of the author and the article. In your opening statement, also state as briefly as possible the writer's main point or purpose in writing the article.

- 4. Refer to main ideas in the same order as in the original text. As you summarize the article, choose the main ideas that you want to refer the reader to and identify them in the same order in which they appear in the original text. Use examples that are essential for understanding the main ideas, but only use examples from the original text – do not include your own examples.
- 5. Paraphrase and use short quotations. Use your paraphrasing skills to review the writer's ideas. Also include short quotations from the original text to give your reader a clear sense of how the writer expressed key points.

6. In the response section, present your views clearly. Discuss aspects you agree and disagree with. Identify ideas that the writer either missed entirely or did not develop completely. Before offering your own suggestions, it can be a good strategy to find at least one positive thing to say about the original writer's ideas. In this way, you can sound thoughtful, balanced, and reasonable.
