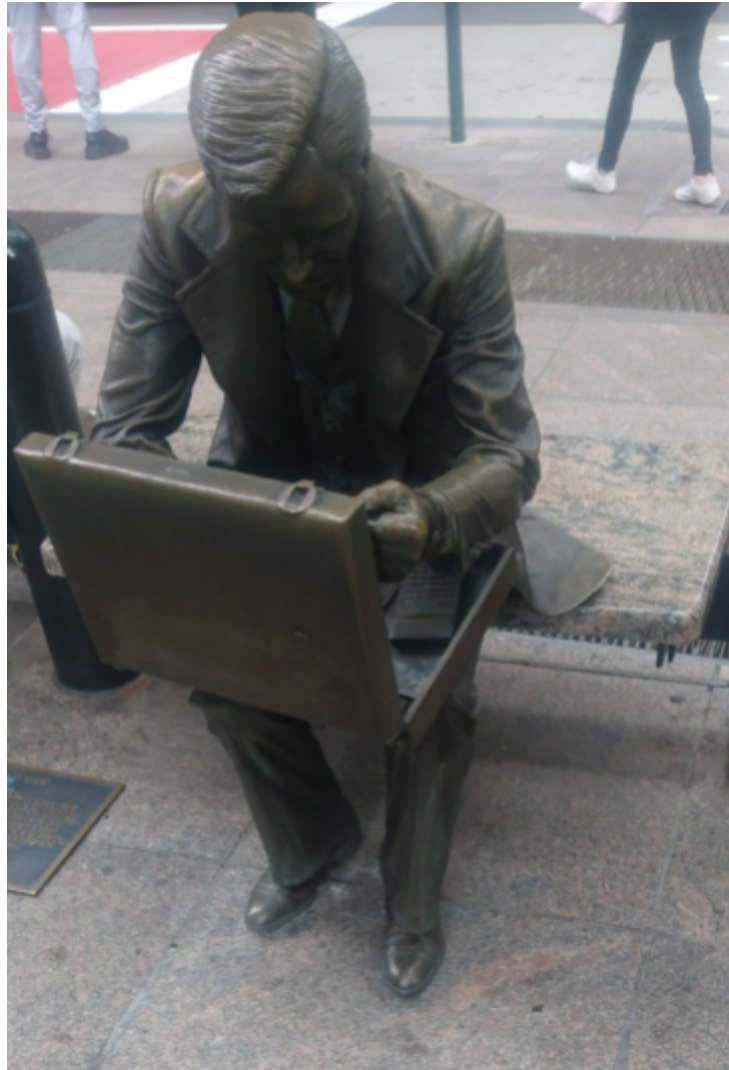

The colors in the surrounding area are very interesting, the whole place has this grayish color to it due to the concrete used to build the floor and the buildings surrounding the area. Then there is this very vibrant green color in the middle of all of it because of the trees that create this very nice contrast as if it should not be there. There is also this big bright red sculpture right at one of the entrance of the park that screams look at me! All of it creates a very interesting experience to the eye.

**How is the natural world integrated into the built environment? Were trees, plants, lawns, and bodies of water established *around* existing architectures, or were the buildings and walkways built to observe preexisting “wild” areas? Describe patterns and methods of integration.**

It seems that the park designers had in mind a place where people would come and sit under the shade of the trees. The hole placement and species of trees in the park where selected in order to create something similar to a roof made out of tree branches. This creates a nice shade where you can hide from the sun and heat during the summer. They also have in place floor lights so people can walk comfortably during the night and at the same time showcase the trees.


**Other than buildings, what are the functions of the designed / built structures (walkways, seating, etc)?**

Judging by the amount of food carts on the side of the park and the sitting areas in the park I would say that it was designed with people having a nice place where they can go and have break from their jobs and eat their lunch in peace. I also noticed that the streets surrounding the area are very narrow and hard to navigate, if someone want to get from broadway to trinity, Zuccotti Park is the place to do it.

Zuccotti Park does not have much in terms of amenities apart from the sitting areas and the food carts but I don't think those really count.

The design of the sitting areas o Zuccotti Park seems to be mostly for people to sit for a bit and then go on their way. This is because the concrete benches are not exactly comfortable so I guess it was made this way to keep a steady flow of people and avoid the place been overcrowded.

By far this park has the most rules I have ever seen on any of the parks I've visited in NYC. I found a sign that prohibits camping, making tents lying on the ground or lying down on the sitting areas, placing sleeping bags, placement of personal property, removing objects from trash cans, and the usual no skateboarding bicycles and rollerblades. I did try to find anyone breaking any of these rules but there was no luck.

There was a lot of people walking by  and sitting in the park but I wouldn't say it was crowded, there was plenty of space for everyone. The sitting areas are not that comfortable but they were good enough to sit there if you are looking for a place to eat lunch.
