When observing the site I noticed two different languages to the surrounding buildings. There was one with a more classical style while the others were more of a modern curtain wall system. They all did however seem roughly around the same height. Looking from the bottom you can't really tell which one is taller than the other. Overall these buildings are generally uniform among the structures.

Some patterns and textures found on the site include, glass curtain wall, structural lighting, there was also greek style columns with ornaments in between the slabs, followed by construction scaffold, and some gargoyles or ornamental statues on the facade of the building. Finally there looked to be like a terra cotta system for the facade.

From what I observed I did not see any natural environment everything was thought of and built accordingly. From the seating areas to the location of the trees in the park. Everything was well thought off and planed. I noticed the seating area had little bumps separated approximately every 2-3 feet I am assuming that was to avoid skateboarders to skate of the seating area. It's a controlled area because there was a lot of cops and maintenance crew patrolling the area.

Other than buildings, what are the functions of the designed / built structures (walkways, seating, etc)?

The walkways were slopped accordingly to the site. I felt like there was a continuous ramp that will bring you across the park. It also served as ADA requirements. The seating area as I mentioned before looked to be strictly for seating purposes only. Because of the bumps added on the seating area it made it more oriented to sit and enjoy your meal or break.

What public amenities are offered to users of the space (water fountains, wheelchair access and other supports for the disabled, public telephones, phone charging stations, WiFi, subway and bus stations, etc.)?

Some public amenities offered around the park include, subway and bus transportation. You also have local attractions such as the 9/11 memorial, the oculus also the freedom tower. There is also a variety food choices to choose from all located on the same area.

I feel the planners and architects have communicated the purpose of the place by creating a lot of seating area with alot of open space, providing shade with the evenly spread trees. They also created a gathering space enough to have a group to have a conversation.

I fell the only rule for this park is not to live here anymore. And I did not see anyone sleeping on the area noor any tents. They urban space is strictly for seating purposes, and that's what I witness for the most part.

This place is generally easy to manage. It is accessible from all street levels, it is certainly not overcrowded. You can find a seat to grab your meal or your brake. I saw they have outlets wrapped in tape, I wasn't sure if that was intended so no one got hurt or they were not public. The seats are like any other polished stone seating, if you are comfortable seating on that material than it can suit you very well. I personally didn't feel very comfortable seating on that material.

My personal take on this public urban space, was fairly pleasant. It did not feel crowded, everyone had their space to enjoy their activity. It wasn't very noisy, apart from an ongoing fire truck. I did hear some bird chips, I felt like the trees on the site blocked some noise coming from the ongoing traffic. The space was fairly comfortable.
