

#### CONSUMERS PROFILE

About 35 billion dollars are spent every year on weddings and receptions. The research by IBISWorld release finding in October 201, found that \$ 48 Billion is spent in the combined bridal market. The target audience will consist of just about everyone who is a potential bride or groom. Many weddings in the United States averages about nine marriages per 1,000 people and are the highest among the industrialized countries. IBISWorld found that bridal gowns are the largest expenditure in the segment. On average, brides spent \$1,100 on their gowns in 2010, according to The Knot's survey.

In the past, the typical engaged woman was about twenty-one years old, lived at home and her wedding was mostly planned by her mother. However, now the bride is mostly older and has more money to spend. Today's median age for first-time brides is 25 years. A second marriage median age brides are about thirty-five years old, grooms were about thirty-eight years old. The brides say that planning their attire was their highest priority. Behaviors and social norms have noticeably shifted throughout the years. Living together before marriage or having children out of wedlock is now largely accepted. These demographics and today's bride are certainly changing the bridal business.


### CONSUMERS PROFILE (CONT.)

In 2014 the Pew Research Center reported that one-fourth of millennials are likely to shun marriage entirely. The was due to four driven factors. The shaky economy, which seen income fall and job stability threatened. However, this group would like to wait for when they are financially stable, before tying the know. Less faith that marriage is permanent. This is rooted in the number of broken homes to which millennials have been exposed to. Next to the rising cohabitation rates. Living together is no longer considered taboo also many couples rather try things out before making a full-time legal commitment to each other. Finally, less formal religious affiliations which decrease the importance of getting married and destigmatizes having a child out of wedlock. The recent end-of-term ruling by the Supreme Court that allowed same-sex couples to legally marry nationwide had established a new civil right and historic victory. It also increased the potential wedding customers. The LGBT Data Overview 2015 by Williams Institute, states that there are nine million LGBT adults in the United States. And only a faction-an an estimated 252,000 couples, according to the U.S. Census Bureau are currently married. What this means is that we are not just selling the bide anymore, you are selling the couple.

## TIME-LINE OF TRENDS

#### 1960'S WEDDING DRESSES

The trend of high boots and white mini-dresses worn in the 1960s pushed into the fore the front. In the early 1960s, the wedding dresses were influenced by Jacqueline Kennedy also got slimmer. Wedding dresses were not modest during 1960. Some dresses got shorter and mutton sleeves were more fashionable. Many of the long-sleeved wedding dresses featured puffy elbows and high necklines. The use of satin was a main character in the 1960s. The Zeitgeist expression looks at the 1960's trend of the hippie culture. The silhouette was still popular in the early 1960s but the elements of a new decade were emerging. The trains diminished in size, vanishing to very little as the minidress hit the scene. The innovative idea to transmit affection, cultural inheritance, and family by incorporating maternal grandmother's costume material into the bride's wedding dress was introduced. The fashions changed more from 1960 to 1969. In the 1960s the average rent was \$98.00 and the cost of a gallon of gas was 25 cents. A 23-inch television cost \$219.00 and wedding dresses changed with the times. After the Great Depression in the '50s, fancy church services were all the rage. The Zeitgeist expression looks at the 1960's trend of the hippie culture. The most expensive wedding dress was the Nightingale of Kuala Lumpur made by Malaysian designer Abdul Faisaly. The red chiffon dress is worth \$30 million.

#### 1970'S WEDDING DRESSES

The wedding dress sleeves got better in the 1970s. Creating the royal star elements. In the 1970's wedding, dresses were loose in the empire-waisted some were Devore velvet. Princess Anne set the trend in an extravagant and Tudor style in the 1970s. In the 1970s Dior introduced a high neck dress with big sleeves and the puff elbow that was the new trend. Dating in the '70s during the revolution and the major social changes in Portugal, influence the style of lace tulips dresses.

#### 1980'S WEDDING DRESSES

The brides ditched the sleeves for the strapless dress in the 1980s. The 1980s was the Hip- hop time period and various wedding dresses got a lot of attention through social media. Because white was hard to obtain or preserve only the wealthier brides could afford such a dress. The celebrity icon Madonna was an inspiration during this time. The tighter dresses were featured in Vogue in the late '80s and became popular. Full skirts gathered at the waistline were brought out by many brides such as the princess in 1980s. Christian Lacroix was a signature designer during the 1980s. Fabrics were bleached when necessary. Kleinfeld started buying some slimmer dresses and selling them quickly.

## TIME-LINE OF TRENDS

#### 1990'S WEDDING DRESSES

The fitted sheath wedding dresses were common, and sleeves eventually disappeared. Less was more during the 1990s. Some behaviors may result in a change in fashion or apparel when people have a change in their needs such as buying houses or cars. A bride would never enter the church or present herself to the guest uncovered because that would be considered a lack of modesty. The average American wedding dress climbed from \$15,000. In 1990 to \$27,000 in 2006, according to a Conde Nast Bridal Media research survey. The slow economy and rising prices have left many couples and their parents feeling squeezed.

In the early 1990s, clothing designs included a lot of decorations with as lace or frills giving the look of exceptional quality and a rich appearance. The signature style of Tom Ford was also relevant during the 1990s. The modern, flirty silhouette dresses caught the bride's interest. Sarah Jessica Parker was considered a bit of a style leader in the 1990s.

The collar was very high and straight up to the chin and small whale bones supported the structure

#### 2000'S WEDDING DRESSES

Wedding dresses were more diversified, in the 2000s so long flowing gowns or tighter dresses were a trend. Marc Jacobs was a designer style for the 2000s. Embroidery and a line were a big trend during this time. The 2000's fashion trends may also be affected when people try to drown the feelings through materialism and consumerism in order to achieve happiness.

#### 2010'S WEDDING DRESSES

In the 2010s sleeves made a royal return. The 2000's fashion trends may also be affected when the rise of massproduction of clothing in lieu of bespoke suits, rather than any personal preference.

In 2013, the average cost of a wedding dress was a staggering \$29,800, which is close to half of a couple's household income. Kate Middleton was also a style leader in 2011. After Kleinfeld made a replica version of the Duchess of Cambridge's Sarah Burton dress, customers showed an interest in sleeves again. Now brides feel comfortable in a wide range of sleeves. History has shown that some dominating events do not have to be positive in order to influence fashion, according to the theory of Zeitgeist. Such as wearing hoodies after the death of a teenager or a famous person.


## TREND: DEEP-V DRESSES
