A quorum was achieved with (4) out of (6) voting members present. Official meeting ensued at 1:07 pm.

Discussions ensued and handouts were given regarding 2016-2017 Year-End financial report.

- a. Expenditures by Major Objects: Numerical and Percent Change for the City University of New York. New York City College of Technology.
 - i. OTPS has been reduced by nearly 5 million dollar, equating to a (26%) drop; while PS (personnel service) regular is up 19.7%, which include an increase of 31.8% of adjunct compensation.
- b. Tuition Revenue Summary for the City University of New York. New York City College of Technology.
 - i. New York City College of Technology collected \$600,000 less than targeted, which is a (-0.7%) than previous year.
- FY2016-FY2017 FTE Enrollment vs. FY2016-FY2017 Tuition Revenue for the City University of New York. New York City College of Technology
 - FTE (Full Time Enrollment of 12 credits) had a slight decline of (-0.7%) FY2016-FY2017.
- d. Total Full Time Staffing: Fall 2015, Fall 2016, Spring 2017 and PS Regular Expenditures for the City University of New York. New York City College of Technology.
 - i. Expenditures on Full Time staff is up 25%.
- e. Technology Fee Summary for the City University of New York. New York City College of Technology.
 - i. Tech fee monies have gone up, due to the fact City Tech is now charging one half of Tech fee for summer students.

- 4. Voorhees Third Floor Renovation (\$14,475): To be requested again
- 5. Campus-Wide Roofing (\$7,150): To be requested again
- 6. Student Activities Center (\$2,400): To be requested again
- 7. Voorhees Hall Remaining Floor Renovations (\$5,425): To be requested again

Reso A Requests

- To be determined after allocation results from FY18 are released.
- Pearl Building Renovations: may become a five-year capital request this year

Notes

- 1. The college will begin to plan the backfill of spaces vacated by groups moving to the new Academic Building 1 (occupancy scheduled for January 2018); the move consultant is currently reviewing plans for AB1.
- 2. Renovations to the Pearl Building will be needed to accommodate groups currently in leased spaces. These renovations will likely be addressed in a new five-year capital request.
