- 1. Call to order at 1:02 pm
- 2. Minutes from November 29, 2021, not available.
- 3. Chair Prof. Anzalone announces a possible switch to Zoom for CC meetings.
 - Testing in new format will take place.
 - Discussion of voting process, including continuing with MS Forums.
- 3. Presentation of Agenda Items from Standing Committee Chairs
 - a) Legislative Committee (Chair: Professor Koca)
 - i. Resolution on Promotion Procedures
 - Proposal was not voted on at last CC meeting.
 - ii. Resolution on Executive Search Procedures
 - Did not pass at last CC meeting. Resolution has been revised.
 - To address concerns that committee could not be formed quickly enough, a search committee pool is proposed with up to 27 members.
 - President to select search committee from pool as follows:
 - Up to eight tenured faculty (rank of Associate or higher) from SoAS, SoPS, SoTD, and the Library.
 - Up to four members from CLT and HEO with at least five years of continuous, full-time service in the title held at the time pool is elected.
 - Up to three students, one from any of the three schools (SoAS, SoPS, SoTD)
 - Motion passes to put this on the agenda at next CC General meeting.
 - iii. Personnel Appeals Committee Discussion

- Vacant seats on this committee. No elections required, per bylaws.
- b) Curriculum Committee (Chair: Professor Sowder)
 - i. 21A: HMGT 4952 course title change
 - Proposal to change course title for HMGT 4952 Hospitality and Tourism Enterprise
 Development to Tourism and Hospitality Entrepreneurship.
 - ii. 21B: Adjustment to Law and Paralegal studies AAS Degree
 - Proposal to withdraw LAW 1201 Legal Research (3 credits) from degree requirements.
 - Proposal to rename/ renumber LAW 2307 Legal Research II to LAW 1200 Legal Research Law (4 credits).
 - Discussion about implications of withdrawing LAW 1201.
 - o Discussion on clarity about elimination.
 - iii. 21C: Changes to Health Communication B.S. Degree Offerings
 - Proposal to add PSY 3405 Health Psychology and PSY 3405ID Health Psychology ID as program electives and contributory courses.
 - Also proposed, that two ID courses be allowed to be contributory (PHIL 2203ID Health Care Ethics and COM 2403ID Health Communication).
 - Discussion of "double duty" for ID courses; alternatives to ID courses and CUNY First issue with ID courses.
 - iv. 21D: Minor Modifications HSCI, BS in Healthcare Policy and Management (HCPM) Curriculum
 - Proposal that students outside of HSA degree be allowed to take HSA courses, by changing prerequisites.
 - HSCI 3101 Health Care Policy and Management to be included as prerequisite for:
 - HSA 3630 Health Care Finance and Accounting Management
 - HSA 4960 Nursing Home Administration
 - HSA 4970 Social Marketing in Healthcare Settings
 - Includes proposal to allow COM 2403 Health Communication as alternative to COM 1403 Intro to Communication in Healthcare Professions.
 - v. 21F: Minor Modification HSCI, AS Health Sciences (ASHS) prerequisites
 - Proposal to allow 2 required biology courses to accommodate students with biology courses above BIO 1101.
 - Change existing prerequisites for HSCI 2301 to reflect this change (BIO 1101 or higher in lieu of BIO 1101).

All curriculum items approved for presentation at College Council.

- c) Building and Grounds: (Chair: Professor Nakamura).
 - i. Discussion of office, classroom and lavatory safety
 - Evidence of mold, rodents and insects in Namm Building.

- Discussion of student survey (through Navigate) to solicit concerns.
- Union leaders and admin met in Fall on these issues.
- Phillip proposes open hearing on health and safety concerns.
- e) Technology (Chair: Professor Isaacson)
 - i. Discussion of Survey
 - Survey sent to all faculty. Now up to 288 responses.
 - Will stay open until President's Day.
 - Preliminary results indicate lack of awareness of existing tech resources.
 - o over 50% did not know how to get Adobe Acrobat, for example.
 - Student and staff surveys are in the works.
- f) Budget (Chair: Professor Budny)
 - i. Discussion of Budget
 - NYCCT received part of federal funding to make up for lower enrollment.
 - 2023 State Executive Budget—senior colleges may receive 8- 10 million to close "TAP gap"
 - Excelsior Scholarship not sustained by students.
 - State to consider covering students in the event of unmet requirements.
 - New lecturer lines being added.
 - 47.7 million appropriated for raises and fringe benefits.
 - Notes 8% drop in fall and 10% drop in spring for enrollment.
 - Notes CUNY Leadership not providing clear guidelines.
- g. Students (Chair: Professor Gregory)
 - i. Discussion of Hunter College Faculty Senate's concerns about changes to grading system.
 - Change of grade policy at CUNY—(I) incompletes discussed.
 - CUNY now considering university-level grade appeals committee.
 - WU policy new as of Fall 2021. What impact on GPA?
 - Meeting mentioned with Provost Brown about forgiveness clause.
