You should focus your studying (but not limit it) to the following terms and concepts!

Paralegal roles and responsibilities

- what it means to be a "certified paralegal" (the qualifications/requirements)
- tasks paralegals may and may not perform, and why (e.g., may not give legal advice or set legal fees)

Workings of a law office

- retainer; retainer agreement
- types of legal fee arrangements *including* fixed; hourly; contingency
- double billing

Ethics and Professional Responsibility

- who determines attorney and paralegal ethical rules
- duties of competence and confidentiality
- conflicts of interest
- unlawful/unauthorized practice of law (UPL)
- consequences to paralegals and attorneys of violating legal ethics

Court systems

- Federal court system *including* District Cts.; Cir. Cts .of Appeals (13); Supreme Court (levels and functions of each)
- New York court system including trial courts; Appellate Division; Court of Appeals
- types of jurisdiction including general; exclusive; concurrent; federal question; diversity; original; appellate
- writ of certiorari (including what it means to grant or deny)

Sources of law

- types of law including statutes; case/common law; administrative law
- primary and secondary authority
- mandatory (binding) and persuasive authority
- U.S. Constitution *including* the Bill of Rights

Legal research

- types of secondary sources *including* legal encyclopedias; digests; annotations
- reporters
- citations
- types of judicial opinions including unanimous; affirm; reverse; dissent; concur

Legal writing

- types of legal writing including pleadings; discovery; general legal correspondence; interoffice/legal memoranda
- types of general legal correspondence (letters) *including* informative; demand; confirmation; opinion
- what paralegals should know when they accept a writing assignment
- when and how paralegals may sign letters; types of letters paralegals may and may not sign

1103 Civil Law and Procedure (second exam—starts approx. 11:15am)

- what "civil law" and "civil procedure" mean
- the body of rules that govern civil procedure (full name and abbreviation)
- standard of proof in civil proceedings
- titles of parties (e.g., plaintiff/defendant; petitioner/respondent; appellant/appellee)
- types of claims, including counterclaims and cross-claims
- consolidation and joinder
- types of civil remedies: damages (including the various types); injunctive relief; declaratory relief
- our hierarchical court system (three tiers/levels)
- distinct roles of trial courts, intermediate appellate courts, and highest appellate courts
- NY and federal court systems, structure and jurisdiction
- the various forms of jurisdiction (e.g., geographic, subject matter, original, appellate, general, limited, concurrent, exclusive, personal ("in personam"), federal question, diversity, etc.)
- non-domiciliary
- long arm jurisdiction / New York's Long Arm Statute
- due process
- names of the current Chief Judge of the New York Court of Appeals and current Chief Justice of the US Supreme Court
- civil causes of action (including tort claims such as assault, battery, conversion, negligence; contract claims)
- commencing an action
- venue (and the various options for proper venue)
- summons and complaint; summons with notice
- pleadings (including pleading requirements under CPLR Article 30)
- preparation of papers
- statutes of limitations
- *all* CPLR sections/rules we have discussed *including* § 104 (Construction); Article 2 (statute of limitations, including specific provisions); § 302 (Personal jurisdiction by acts of non-domiciliaries); § 503 (Venue); § 601 & 602 (Consolidation and joinder); Article 30 (pleading requirements); *and others*.
