Timekeeping assignment! relates to "Workings of a Law Office" which we'll discuss Tues. Oct. 25!

<u>Timekeeping</u> = Paralegals' and attorneys' practice of keeping track of the amount of time they spend on various professional tasks, like meetings, phone calls, and legal research. They record the time in fractions of hours, such as quarter-hours (15 minute increments) or tenths of an hour (6 minute increments). Law offices use these records to bill their clients for time spent working on those clients' cases.
