Law 1201/Legal Research I/Coughlin/Spring 2021

**Assignment:** Oral presentation! (5% of course grade)

Overview: Each student (or team of two students) will give a five-minute oral presentation on a "Practice Pointer" or "Ethics Alert" in our Legal Research textbook, and post a short summary on OpenLab in advance of the presentation.

Instructions: Our textbook, The Legal Research and Writing Handbook (8th ed. 2018), includes "Practice Pointers" and "Ethics Alerts" in each chapter, set off from the main text in boxes, highlighting important information paralegals and attorneys should consider when conducting legal research. Here are some examples, from page 11:

## PRACTICE POINTER

State and federal courts can decide issues of state or federal law.

## ETHICS ALERT

If you are assisting an attorney in preparing a claim, be certain that the claim is made in a court that has jurisdiction over such a claim.

Each student or team will choose one "Practice Pointer" or "Ethics Alert" from the textbook and give a five-minute oral presentation on it to the class. The presentation need not be fancy or high-tech! Most important, presenters should explain the pointer or alert, and why it is important for paralegals and attorneys to follow. You can do that in any way you think is effective: discuss an example of how the issue arises in real life, or potential consequences of failing to follow the pointer, or pose a question to the class, whatever you'd like! You will probably need to read more than just the "Pointer" or "Alert" itself, which is only one or two sentences like the ones above, to give a quality presentation. You might want to read other relevant material in the chapter and/or outside research—be sure to cite your sources!!
