Political Stability

Since 2010 Mark Rutte has been elected to be the prime minister of The Netherlands. He leads his country in the people's party for freedom and democracy and has become one of the most popular figures of The Netherlands. The Gross domestic product of the Netherlands is worth \$902.36 Billion (Silver, 2020). Which is a good indicator of a healthy and stable economy and its worth to establish a business in the country. Its regulations give companies the opportunity to grow and have the independence to use new methods and ideas for new product developments and allow businesses to magnify productivity (Netherlands. Retailing Practices

Just like in most places in the world, the Netherlands' footwear, attire, and sizes are measured differently. For example, a women's footwear in the US is size 5, in the United Kingdom size 3 and in Dutch, it would be converted to a size 36. According to "Useful things to know about opening hours in the Netherlands" (2019, August 16), the majority of stores located in the Netherlands operate from Monday-Sunday with hours differentiating each day. The majority of the week hours operate from 10 am-6 pm, while Monday's store hours tend to be from 11 am-6 pm, Thursdays are 10 am-9 pm while Sundays are from 12 pm until 6 pm in the afternoon. The average time span of opening a business in the Netherlands takes roughly about

seven days. It is also a mandatory requirement to check that the company's name is appropriate and valid, this process however only takes a day(Legal, K, 2018). In order to establish a business at a particular location, this choice of location must be in line with the municipal zoning plan. This plan includes detailed rules on the land or area that can be used(Zoning plan,(n.d)). When creating a business you must choose a legal structure with or without corporate personality that must be registered at the Netherlands Chamber of Commerce(Business structures in the Netherlands: overview,(n.d)).
