Gerarda and Pam,

I have reviewed the CUNY Climate Crisis RFP.

I believe applying for the grant can support the AMPS conference as follows:

1. Support the selection, honorarium and travel of the keynote speaker that we can select.
2. Support for one or two students as Research Assistants that can help with research and preparation for the conference.
3. Support a student exhibition (printing expenses, supplies, student team to coordinate.)
4. Support use of the Igloo for special immersive presentations as part of the conference (can include student presentations.)
5. Conference supplies
6. The conference grant can include space costs, but I am not sure if that applies to our use of the campus.

We should form a team that represents critical social, economic, political, and scientific perspectives for this conference and can join the grant application.

The RFP also strongly suggests faculty from other CUNY institutions. I reached out to a professor of psychology at LaGuardia College, Eduardo Vianna, who may be interested. If you have recommendations of other faculty across the University let me know.

On our campus I am thinking of Ben Shepard, Reginald Blake, Sean MacDonald, Diana Mincyte and Javiela Evangelista (I realize she is on leave at the moment.)

Let me know what you think of this strategy and if there are others to consider.

The RFP also requires a path for new external funding to continue the efforts. I would like to discuss this aspect further to develop a strategy.

I am starting the application now and will send a draft later this week for review.
