



The Mayor wants to invest into better maintenance by partnering with other companies to provide better quality towards the residents in NYCHA public housing. This idea will take the cleaning portion of the Public housing off of NYCHA shoulders. A major problem de Blasio spoke was the age of these buildings. Most of them are over a half century years old which makes the technology from then not compatible with modern technology. The mayor is building a better service plan that will hire and invest more money towards this service plan that will allow residents to get better quality service when dealing with any problems with their homes (For example roof leakage and Damage pipes for heating and Water.
