

#### PART 1: SITE OBSERVATIONS

On the day of the site visit, we walked through a neighborhood of South Brooklyn aka Gowanus. The community is now a mix of old brownstone houses lined up along the streets and some old industrial buildings that have been changed into residential buildings as well. Once you reach the intersection of President Street and Bond Street you will witness the more gentrified version of this area. Once we were on the Union street bridge which was undergoing renovation, we got the opportunity to witness the state of the water that fills up the Gowanus Canal. The water is polluted by combined sewer outflows that runs along the canal which was initially constructed to relieve the sewage and storm water when the sewer treatment plant got overwhelmed.

- 1. What are some general observations about the character of this neighborhood? What does it remind you of? How does it make you feel?
  - On the way to the Gowanus the block was lined with beautiful brownstone houses. Some old warehouses were modernized into new loft style buildings. You get the old western town kind of vibe walking in the neighborhood.
- 2. How is the natural world contained or shaped by human activity or architecture? In what ways does the natural world invade or disrupt human activity, planning or architecture?
  - The water in the Gowanus is contaminated with PAHs (Polycyclic Aromatic Hydrocarbon), VOCs (Volatile Organic Compound), PCBs (Polychlorinated Biphenyl), pesticides and metals. Human plays a major role in creating these contaminants and are also responsible for dumping it in the water. The life that are present in the water is affected by this. The nature is also disrupting the architecture by some invasive plants such as Paulownia tree which is growing very aggressively in the surrounding neighborhood.
- 3. What people did you observe in the neighborhood and what activities are they engaged in?
  - Since it's an industrial district and still has lots of factories. People here are mostly people working in those factories. There are people who also reside in this community.
