Most of the audience of the place will be attorneys, jurors, witnesses, court interpreters and the defendants who go in and out of the court. Some other audiences are people in the farmers market, people who come to relax on the side bench, students and commuters from in and out of the subway station

 - People usually come to this place to relax during their break time or free time, there is plenty of seats where people can sit and watch either the activities in the farmers market or birds in the park. The program of the place is meant to be a city square where people can interact with one another, but this place is been illegally used by some teenagers by riding bikes and skate boards. This is a good place for people to loosen up all their stress by sitting under sunlight and being with the environment, people spend their break time from office work in this place to calm themselves and being able to work more productively.

 - The major activity that people are currently engaged is in the farmers market, there are plenty of people walking around from one cart to another to buy fresh organic vegetable and other baked items. Why did you select this source? How does it address all or part of your research question?

In the journal it contains information about some of the existing transportation programs offered by the department of education for the eligible students. Free bus rides from home are available for special education students or accommodation for students with DOE approved medical conditions. There are also either free or reduced metro cards provided for high school students, these special metro cards are different from the regular metro cards, students can only get 3 rides and 3 transfers per day in the metro card provided by the DOE. This site has some of the information which can give an answer to the question.

Yes, this source is credible because it is a government authorized site of NYC schools. In the site there are also information regarding why the school buses are running late and how to contact them.

Why did you select this source? How does it address all or part of your research question?

Accelerated Study in Associate Programs (ASAP) is a comprehensive program for the students offered by the CUNY to provide free metro cards throughout the semester. It is considered as a program to fight poverty through education, and it's a motivation for students to earn a degree and succeed in life. ASAP is only offered in the first two years of the student's curriculum or until they get an Associate's degree, according to the statistics ASAP students had a three-year graduation rate of 52.4%, 25.6 % higher than the comparison group's rate of 26.8 %. If ASAP program becomes available in a national level it can be funded by federal grants.

Is the source credible? Why or why not?

Yes this source is credible because it is based on an existing CUNY program posted in the official CUNY website. CUNY articles are peer reviewed and only reliable educational related information are posted in the page.

What further information would you need to answer your question? Where would you look for additional sources?
