Throughout the article, "The Black Panther" from September 7, 1968, African, Asian, and Latin Americans were limited and restricted from using firearms created by California and Federal Gun Laws. The Black Panther Party consisted of members who joined forces to help the community and those who did not get help from the police and the power. The police department abused its power by targeting the Black Panther party members. Black Panther members would go missing, kidnapped, and killed by Police. People of color had disadvantages compared to the racists, so people of color had to defend themselves. The Black Panther Party calls on all the black and white communities to help contribute to the underprivileged black community. Police slowly try to get rid of the Black Panther Party members illegally.

In the article, "Black People: Keep Your Guns" from September 7, 1968, in *Black* Panther written by California and Federal Gun Law, the Black Panther party members are looking out for each other members by putting out the California and Federal Gun Laws for those who have the possessions of guns in case they were to face law enforcement. The Black Panther members were not allowed to carry firearms on their bodies or their vehicle if they were to disobey then they would be charged with a misdemeanor. It was not required to have a license for 18 years old and older who owned a weapon, as long the weapon is within their house or business. Although certain weapons require registration. However, members of clubs and organizations that use firearms for practice were exempt from Section 12025. If the police stop people to check, they would have to follow the police's order and if they disobey then they are guilty. This shows that the Black Panther Party is restricted and limited on what they can do to protect themselves and the black community who are underprivileged. Police were allowed to examine a loaded firearm if a person feels they were in danger and thinks it is necessary to carry a gun. If a minor have a furnished gun without their parents or guardians supervisions and permission then they are guilty and charged with a misdemeanor. If someone who had a history of crime and who were behind bars who carried a firearm will be punished by going to jail but imprisonment does not reach greater than 15 years and in a county jail the imprisonment does not reach greater than 1 year and the fine does not reach greater than \$500. Under Federal Law, those who train and teach others how to use a firearm during riots and protests may be charged and be sent to jail for up to 5 years and can be fined up to \$10,000. Others who were a felon, unhonourable, no citizenships, or even former citizens were not allowed to possess firearms if they do then they would be fined \$10,000. Tax skyrocketed under the The National Firearm Act if fully automatic firearms were purchased. By December 16,1968 most licensed dealers or manufacturers were able to transport and deliver firearms.

In the article, "Black People: Keep Your Guns" from September 7, 1968, in *Black Panther* written by California and Federal Gun Law, the Black Panther Party member announces and listed regulations to other members who possess firearms and to the communities who are not protected by police and the power. The Black Panther Party and minorities were limited on when to carry firearms, where to carry firearms, and when to use firearms. Policies had the right

to check firearms by law. Black Panther members can barely defend themselves against any perpetrator. The Black Panther Party is always targeted by the police.
