Good afternoon Provost Brown and Dean Smith,

I hope this finds you both well and enjoying this beautiful day. Pardon the weekend email, however I just received the forwarded email from a manuscript that I been attempting to publish for the past few years.

This article stems from the original that Prof. Susan Kupsch spear-headed from our DEN 1200 course. I was successful in obtaining an IRB last year and revised the manuscript to be broader in a general journal writing sense, and only used one set of data from the three sets (class sections) in the original paper.

Unfortunately, due to the small nature of these results, several dental publications have declined the manuscript. I received the predatory document from Provost August and upon receiving all the paperwork from the publisher, was hesitant.

I have been in contact with Monica who has provided much guidance and assistance to determine the efficacy of this publication. Here is her comments:

"The Journal of Allied Health is the official publication of the Association of Schools Advancing Health Professions, a non-profit scholarly society based in Washington, D.C. that supports allied health education. This is a traditional, non-open access society journal that uses page charges as an integral means of income in addition to subscription fees to libraries. Some society publishers in the sciences continue to employ the page charge model for income. These charges are not article processing charges (APCs).

The journal pays to have its content hosted on IngentaConnect, a high profile international journal portal that is owned by Taylor & Francis, one of the big five commercial scholarly publishers. They also continue to print and mail the journal to subscribers. This is a small publisher. The journal lacks an impact factor but it is indexed in Scopus, another important positive indicator of quality. There is absolutely no evidence that this publisher is involved in any exploitative, deceitful, or deceptive practices."

I would love to see this published as I put much time and work into it and hope you agree.

Although some authors may obtain support from their respective institutions, most of the work published in our journal does not have extramural funding. Advertising revenue is non-existent and subscription revenue does not come close to offsetting personnel costs; expenses associated with printing and mailing; and having outside vendors manage our publication electronically and placing each issue on the Internet.
