The first phase took place in Asia, around a quarter-century after the war, as part of a wider effort to restrain communism and link the region's developing new economies to the United States through export-led development a policy that failed miserably. During

this time, a new trade system was established and enforced on the textile and garment sectors in the United States (Rosen 2002, p. 6-7).

c. What is Rosen's definition of a sweatshop? Why were unions created? How did the incident at the Triangle Shirtwaist Factory in New York City have an impact on unions? On women? (5pts)

Rosen's definition of a sweatshop is a factory in which employees work for long hours at low wages and under unhealthy conditions. Unions were created to seek for employers right, to ensure fair wages, benefits and better working conditions for their members. The fire at the Triangular shirtwaist factory in New York City in 1911 brought attention to the sweatshop conditions in which women worked. Due to the incident at the Triangle Shirtwaist Factory, a lot of female immigrants workers were burned to death or died when they jumped from a window in the building's lone fire escape. However the Triangle shirtwaist factory fire prompted positive changes towards female workers afterwards when the International Ladies' Garment Workers Union's (ILGWU) strength was felt during the New Deal and the early postwar years of prosperity. Sewing operators who were members of the ILGWU received decent wages, paid vacations, and medical benefits, and could claim unemployment insurance from the federal government when business was sluggish.
