How have gangs involved youth with violence and become widespread?

Introduction

I am interested in this question because I am almost certain that not everyone has been aware of gangs and gang violence and if they do, I think it is important to show that there is a lot of youth being involved in these gangs. However, New York City has been the state with the most common gang violence in the past 10 years. I am personally interested in this topic because gang violence happens on a daily basis with and without being on camera. My highschool personally had a lot of gang violence in and outside of school which was always involving someone getting hurt very badly and sent to the hospital, or even have "gang fights", which means that a group of people fight another group of people. Sometimes the fights would be just for fun, and then sometimes it would actually be so bad that the security guards have to physically stop the fight in the teacher's classroom. Even sometimes the teachers would get hurt just because the kids fighting would go near them without knowing and mess up their items and the teachers themselves teaching or not teaching. And because of this, I've noticed that violent gangs usually attract the youth group at a young age. Through my research, I hope to find out a lot of information as to why and how gangs came to be violent, how did it become widespread,

and why do young kids get involved with it. Honestly speaking, I believe that the youth are attracted to the gangs as a sign of acceptance considering their background.

Since the mid-20th Century, gang violence in this country has become widespread. All 50 states and the District of Columbia have reported gang problems (Howell, 2012). This issue severely ruins the lives of youth, who predominantly join gangs. Data from the National Gang Center surveys found that during the mid-1990s to the early 2000s there was a decline in gang problems. However, the prevalence of gang activity greatly climbed between 2001 and 2005 and has since remained constant. According to the National Gang Center, a 2012 survey indicated that larger cities and suburban counties accounted for the majority of gang-related violence. New York is a large urban center. The New York Police department (NYPD) Chief Terence Monahan said 30 percent of homicides in the city are gang-related while 40 percent of non-fatal shootings are gang-related (Moore & Feis, 2018). These percentages are significant.

One of the most well-known events involving gang violence occurred in the Bronx when Guzman-Feliz also is known as Junior fell victim to gang violence. Members of the offending gang were aged 18 to 24 and had mistaken the young boy for someone else. Junior was stabbed multiple times in the street with machetes and knives. This gang the Trinitarios were also found to be responsible for two other murders. Almost every year there are accidents related to gangs. There was a 15 percent increase in youth gang problems reported in the National Youth Gang Survey (NYGS) from 2002 to 2008 and it has been steady since then (Egley, Howell, and Moore, 2012).
