During the early days of the pandemic, CUNY Professors were prompted to develop an online presence with their students, in ways they hadn't before. Having observed Professor Mazumdar's online teaching once before, I can attest to the growth and positive impact of her asynchronous teaching. This latest virtual course is no less impressive and can be described in just one word: ENERGY.

The professor's course checks every mandated box:

- Announcements are posted and updated regularly
- There is a thoughtfully designed course syllabus with embedded links, directing students to campus offices where they may find support and answers to their questions
- Weekly expectations are outlined clearly
- Assignments are posted and returned in a timely manner
- Students have access to the professor, via weekly office hours
- Site is easily navigable

Most importantly, Professor Mazumdar's course is bristling with energy. In a word, it is colorful—utilizing memes, cartoons, and diagrams that engage students and fully detail the week's expectations. It is imaginative and bold—tools sorely needed as professors work toward navigating evolving modalities in teaching.

Professor Mazumdar appears to enjoy a healthy rapport with her students. An in-person "feel" permeates her Blackboard classroom design. Students have regular access to her through office hours and email; moreover, they thoughtfully engage, via their virtual learning environment.
