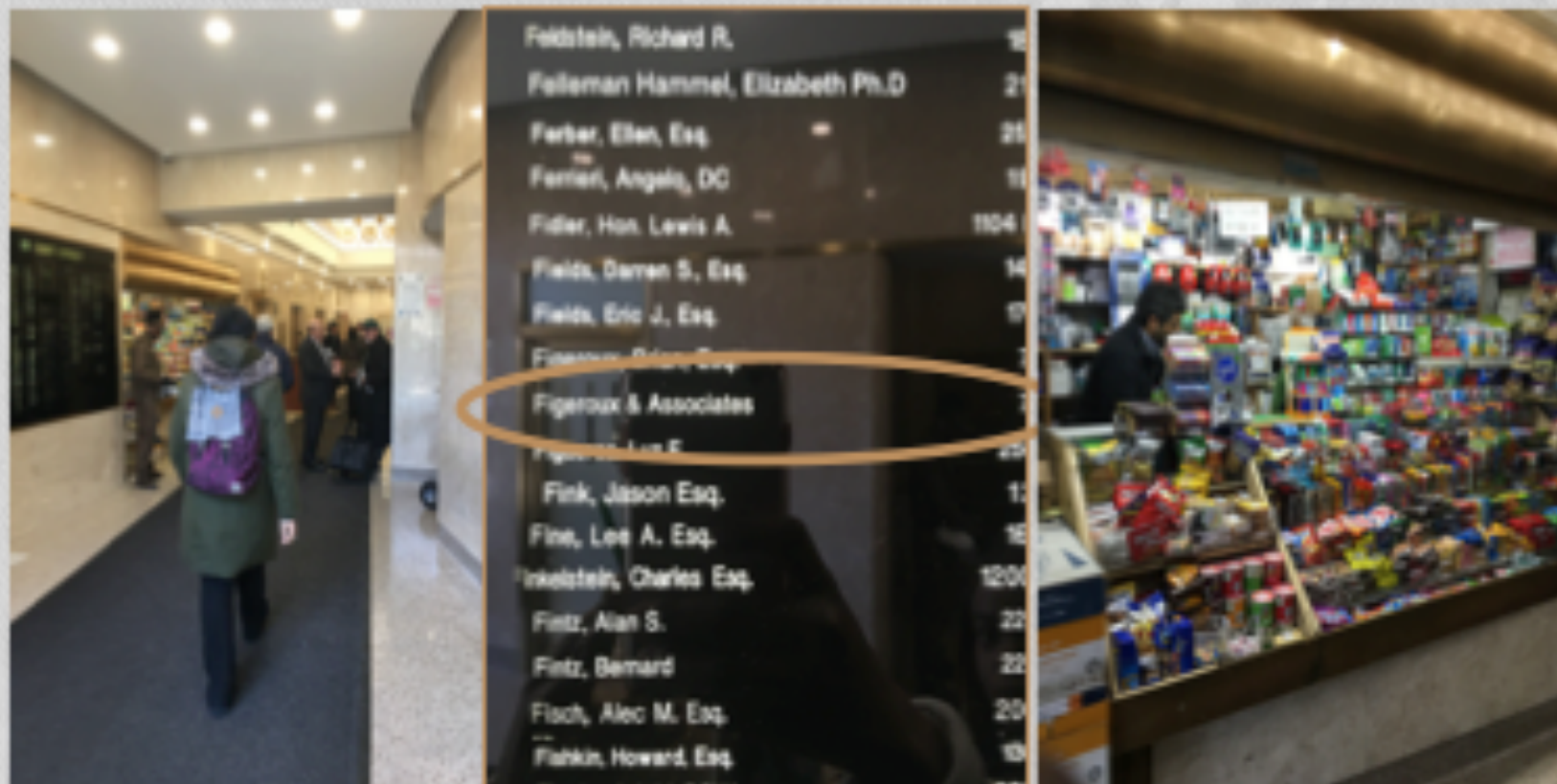

What is Caribbean American Weekly?

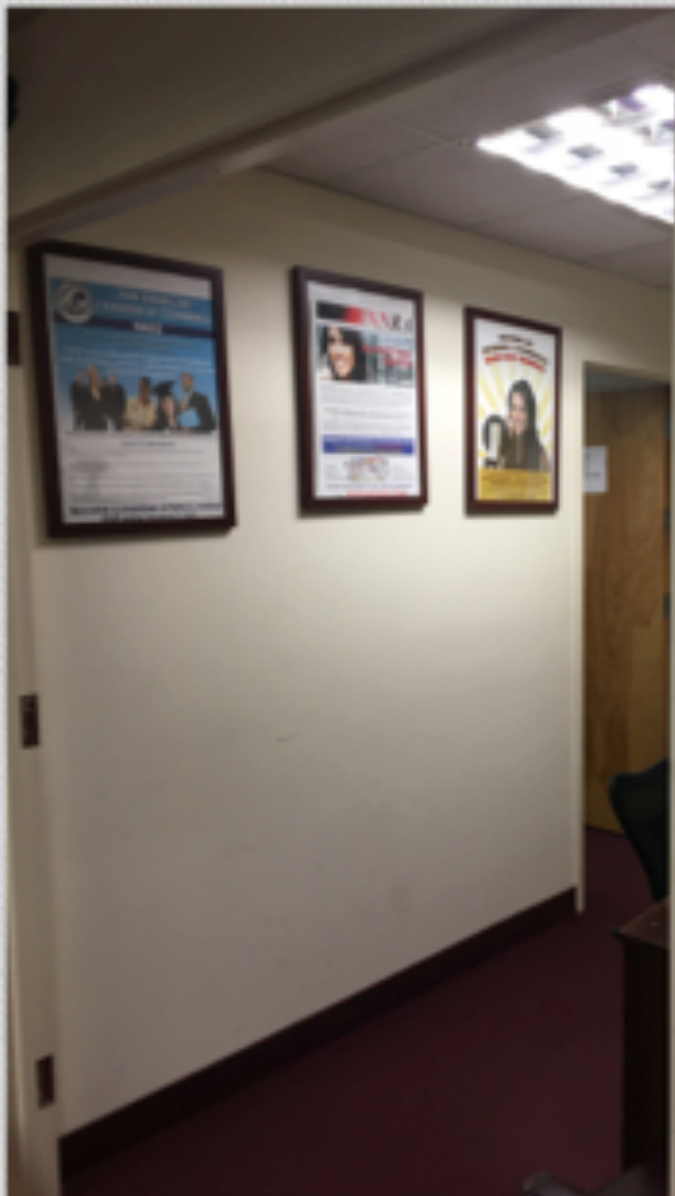
